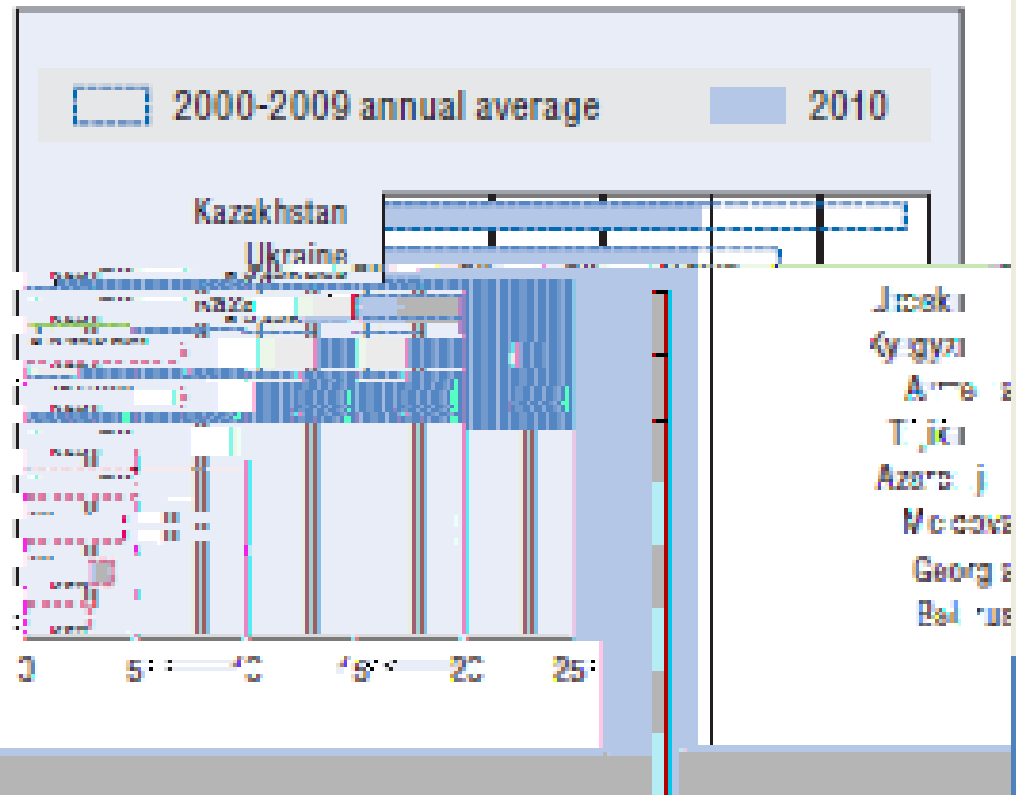

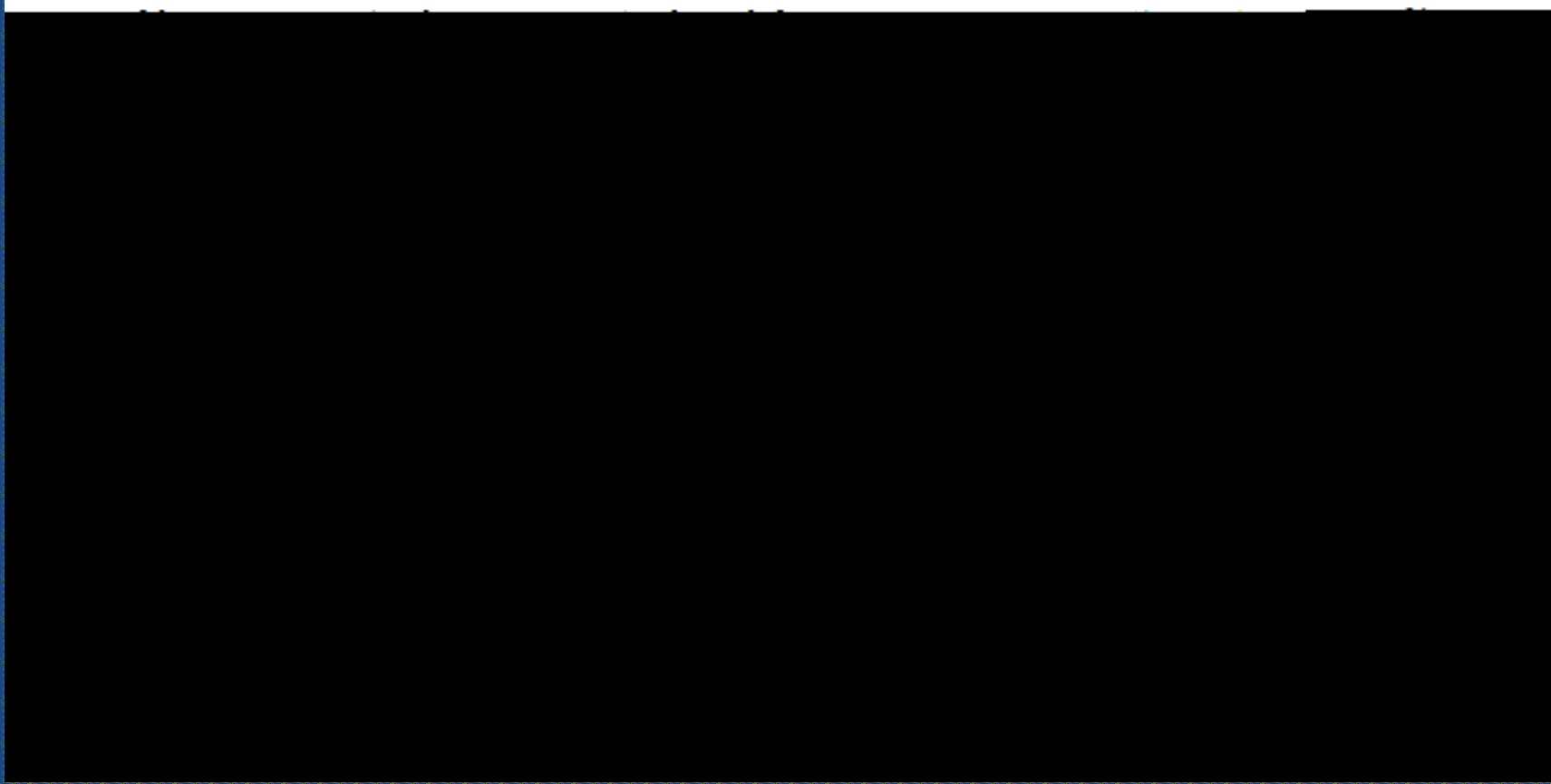

- 2005 - 2007 *The State Committee of Kyrgyz Republic on Migration and Employment* On 07.08.2007, the Migration Fund for accumulation of finances/ implementation of state policy.
The Ministry of Labour, Migration and Employment (MLME)
- 2011-2012 *Ministry of Youth, Labour, Employment and Migration*
merged Ministry of Labour, Migration, Employment with Ministry of Youth Affairs . Dissolved Feb.2012.

Best Practices: Bilateral Agreements

- 14 MOUs with sending countries.

- Single agency with authority, high level status to ensure budgetary allocations as needed
- Stakeholder input from migrants, employers, experts
- distribute job-matching information in host countries for Kyrgyz migrants'
- System of monitoring migrant abuses in host countries--regulation and redress for violations to migrants rights via:
 - national laws
 - bilateral agreements
 - regional collaboration w/like-minded countries (Colombo Process, CSTO)
